

## **PURCHASE OF KANADA-YA TRUFFLE RAMEN E-VOUCHERS - TERMS & CONDITIONS**

  - (i) Fave; and
  - (ii) Qoo10.(“Platforms”).
2. The E-Vouchers are only available for purchase from 1 May 2020 to 31 July 2020 or until the E-Vouchers are sold out, whichever is earlier, unless otherwise decided by Kanada-Ya.
3. The E-Vouchers are can only be redeemed by dine-in (after Circuit Breaker measures are lifted) and takeaway customers only from 11am to 9pm. The E-Vouchers cannot be redeemed through any delivery services.
4. The E-Vouchers are valid until 31 August 2020 only (“Expiry Date”) and there shall strictly be no revalidation of vouchers or any extensions beyond the Expiry Date.
